## Kelso Dancing Rules and Entry Information

1. Dance competitions will run under the rules of the SOBHD.
2. Start times & Schedule will be available online.
3. Any dancer causing a delay will forfeit his/her entry in event. It is dancer's responsibility to follow platform schedule.
4. First to enter, last to dance.
5. \$2 from each entry goes towards FUSTA NW Region.
6. All groups will receive medals except adult premier class who will receive cash awards. An aggregate trophy will be awarded in each class except Primary.
7. A total of all National and Highland dance points will be combined to figure overall aggregate trophy points
8. The **Aronson Memorial Perpetual Trophy** will be awarded to the Premier dancer of the day. If any Premier group drops below 6 dancers a dance off of all premier trophy winners will be initiated.
9. Age groups will be split according to entries.
10. Age is determined as of day before competition.
11. All judges' decisions are final. A \$30 protest fee must accompany any formal written protests.
12. **Choreography -Premier Dancers only**
  - ❖ Supply own music-CD/tape- 3-min max.
  - ❖ **Must have Celtic theme and use Highland/ National movements.**

1. Entries must be **postmarked NO LATER than 8- 30- 17**. Competitors wishing confirmation of their entry please email [casehighlanddance@gmail.com](mailto:casehighlanddance@gmail.com)
2. Please call Jocelyn Case with late entries. 503-358-5791
3. **All fees must be payable in US funds.**
4. Competitor numbers will be picked up on day of competition. Dancers must show current registration card.

Kelso, Washington sits approximately 2 hours south of Seattle or 45 minutes north of Portland, Oregon.

### Directions to Tam O'Shanter Park in Kelso Washington:

From the North: I-5 Southbound take exit 39. Make a left at the light on Allen Street- SEE BOTH

From the South: I-5 Northbound take exit 39 make a right on Allen Street.

BOTH: Take a right on Kelso Drive. Continue past strip mall BEFORE bridge turn left into park entrance. Park in Rear of **Tam O'Shanter Park**. Dancing is at the far end of the park.
