- 1. Dance competitions will run under the rules of SDUSA & RSOBHD.
- 2. All attendees must comply with local & state covid guidelines.
- 3. No refunds given.
- 4. Start times & Schedule will be available online.
- Any dancer causing a delay will forfeit his/her entry in event. It is dancer's responsibility to follow platform schedule.
 First to enter, last to dance.
- b. First to enter, last to dance.
- 7. \$2 from each entry goes towards SDUSA NW Region.
- 8. All groups will receive medals except adult premier class who will receive cash awards. An aggregate trophy will be awarded in each class except Primary.
- 9. The **Aronson Memorial Perpetual Trophy** will be awarded to the Premier dancer of the day. If any Premier group drops below 6 dancers a dance off of all premier trophy winners will be initiated. Seann Triubhas 3&1 to be danced.
- 10. Age groups will be split according to entries.
- 11. Age is determined as of day of competition.
- 12. All judges' decisions are final. A \$40 protest fee must accompany any formal written protests.
