Upon motion by Councilmember Lefebvre, seconded by Councilmember Alexander, 'Adopt Ordinance No. 19-3938, 'AN ORDINANCE OF THE CITY OF KELSO AMENDING CHAPTER 5.02 AND 5.03 OF THE KELSO MUNICIPAL CODE TO BRING THE BUSINESS AND OCCUPATION TAX PROVISIONS INTO CONFORMANCE WITH STATEWIDE MODEL ORDINANCE REQUIRED BY CHAPTER 35.102 RCW.' Motion passed, all voting yes.

Resolution No. 19-1215 – Authorizing an increase in the Regular Property Tax Levy: The Deputy Clerk read the proposed resolution by title only. Upon motion by Councilmember Lefebvre, seconded by Councilmember Alexander, 'Pass Resolution No. 19-1215, 'A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELSO AUTHORIZING AN INCREASE IN THE REGULAR PROPERTY TAX LEVY IN

ADDITION TO ANY AMOUNT RESULTING FROM NEW CONSTRUCTION AND IMPROVEMENTS TO PROPERTY, NEWLY CONSTRUCTED WIND TURBINES, AND ANY INCREASE IN THE VALUE OF STATE ASSESSED UTILITY PROPERTY.' Motion passed, all voting yes.
